TOURNAMENT RULES: Standard rules of Bergen Bassmasters and the NJBF apply and will be reviewed the morning of the tournament. Boat owners must be 18 years of age to participate. Riders with parent or guardian may be 16 years (written permission required). Boat numbers assigned during boat check at Dutchman's Landing.

GENERAL RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT: By signing this release and waive of rights, I am giving up my right to sue the Bergen Bassmasters, New Jersey Bass Federation and TBF and releasing them and holding them harmless even from the effects of their own negligence, for any personal injuries I may sustain while participating in said tournament. I understand that this release is legally binding, and even if I am injured or killed due to negligence or wrongful conduct of a Bergen Bassmasters, New Jersey Bass Federation member and/or the TBF, and/or their members, directors and officers, that I cannot sue or make any claim to recover for such injuries. If someone intentionally injures me, the release will not prevent me from suing them or making a claim for personal injuries. This release is intended to be binding upon my spouse, my estate, my personal representative and/or my beneficiaries or dependants. I understand that there is good and valuable consideration for the making of this release. I understand that I am giving up the right to sue members of the Bergen Bassmasters, New Jersey Bass Federation and/or TBF and that they are giving up the right to sue me. I understand that I do not need to sign this release, waiver and hold harmless agreement, and that I am not forced to sign this release and waiver. However, unless I sign this waiver, intending it to be binding, I cannot participate in the fishing tournament conducted September 27, 2009.

Obtain low boat numbers by registering in advance (\$200 payable to the Bergen Bassmasters). Advance registration checks must be received by September 10, 2009. Late registration (cash only) will take place September 27, 2009 in person at the Dutchman's Landing ramp.
